What is a Community Foundation?

A Community Foundation is a not for profit organisation dedicated to improving a local community by addressing community needs and supporting local causes. They enable a wide range of donors to give to causes in their own local community, now and for the future.

The purpose of a Community Foundation is to pool the charitable gifts of donors to create a permanent income-earning endowment fund. The income earned by the fund is donated to local community causes, whilst the original investment continues to grow over time.

Community Foundations are one of the fastest growing forms of philanthropy in the world. Established over 100 years ago in the United States, Community Foundations have proven to create long-lasting positive transformation in communities worldwide.

New Zealand's Community Foundation movement began in 2003, with the support of The Tindall Foundation. Currently Community Foundations support philanthropic activities in all the main regions around New Zealand, covering over 80% of the country.

As philanthropic experts, Community Foundations connect generous people with meaningful giving options, provide philanthropic advice and community leadership.
